

SCANSOURCE 2017 APG CASH DRAWER DRIVE TO SUCCESS SWEEPSTAKES
OFFICIAL RULES

The ScanSource 2017 APG Cash Drawer Drive to Success Sweepstakes (the “Sweepstakes”) is sponsored by ScanSource, Inc. (“ScanSource” or “Sponsor”) and is open only to “Resellers,” which for purposes of these Official Rules, are defined to mean individuals who are legal residents of, and business entities that are domiciled in, the 50 United States and the District of Columbia and Canada (except the Province of Quebec), which at the time of entry are: (1) 21 years of age or older (if an individual); (2) registered resellers, integrators or service providers of ScanSource; and (3) in good financial standing with ScanSource. Direct Marketers (“DMARS”), “e-tailers,” distributors, manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes.

For purposes of the Sweepstakes drawings, Resellers will be divided into two (2) groups: (1) Resellers that, between April 4, 2017 and July 4, 2017, have purchased APG Cash Drawer products from ScanSource (“Current APG Resellers”); and (2) Resellers that, between April 4, 2017 and July 4, 2017, have not purchased APG Cash Drawer products from ScanSource (“New APG Resellers”).

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT ENHANCE A RESELLER’S CHANCE OF WINNING. SWEEPSTAKES VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS, THE PROVINCE OF QUEBEC, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. SWEEPSTAKES PERIOD. The Sweepstakes begins July 5, 2017 and ends March 31, 2018 at 11:59:59 p.m. (Eastern Time) (the “Sweepstakes Period”). Sponsor’s clock is the official time-keeping device for this Sweepstakes.

2. HOW TO ENTER. Resellers may enter and receive entries in the Sweepstakes the following ways:

(A) Automatic Entries by Purchasing Products. A Reseller may enter and receive Sweepstakes by purchasing APG Cash Drawer products from ScanSource during the Sweepstakes Period. A Reseller will automatically receive:

(a) twenty (20) Sweepstakes entries, if the Reseller purchases \$20,000 - \$24,999 in APG Cash Drawer products from ScanSource during the Sweepstakes Period;

(b) forty (40) Sweepstakes entries, if the Reseller purchases \$25,000 - \$29,999 in APG Cash Drawer products from ScanSource during the Sweepstakes Period;

(c) sixty (60) Sweepstakes entries, if the Reseller purchases \$30,000 - \$34,999 in APG Cash Drawer products from ScanSource during the Sweepstakes Period;

(d) eighty (80) Sweepstakes entries, if the Reseller purchases \$35,000 - \$39,999 in APG Cash Drawer products from ScanSource during the Sweepstakes Period; and

(e) one hundred (100) Monthly Sweepstakes entries, if the Reseller purchases \$40,000 or more in APG Cash Drawer products from ScanSource during the Sweepstakes Period.

By way of example, a Reseller that purchases APG Cash Drawer products from ScanSource totaling in the amount of \$31,000 during the Sweepstakes Period will automatically receive 60 Sweepstakes entries.

(B) **Mail-In Entries.** A Reseller may also enter and receive entries in the Sweepstakes without purchasing APG Cash Drawer products by hand-printing the Reseller's name, address, city, state, zip code, email address, and phone number, and the words "ScanSource 2017 APG Cash Drawer Drive to Success Sweepstakes" on a 3"x 5" card, and mailing the card in a stamped envelope to: ScanSource 2017 APG Cash Drawer Drive to Success Sweepstakes Entries, ScanSource, Inc., 6 Logue Court, Greenville, SC 29615 (USA). A Reseller will receive one (1) entry in the Sweepstakes for each such mail-in card that is submitted during the Sweepstakes Period. ***Only one (1) mail-in Sweepstakes entry per stamped envelope will be accepted. Mail-in entries must be postmarked by March 31, 2018 and received by April 6, 2018.***

(C) **Limitations.** ***Limit a total of one hundred (100) Sweepstakes entries per Reseller, regardless of method of entry.***

(D) **General Entry Matters.** No copies or mechanical reproductions of mail-in entries will be accepted. Any illegible, unintelligible, postage due, incomplete, or garbled entries are not permitted and will be disqualified and any entries not in conformance with these Official Rules will be disqualified. Neither Sponsor nor any of its employees, representatives or agencies, is responsible for lost, late, postage-due, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. Once submitted, entries become the exclusive property of Sponsor and will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor. By entering, entrants give their express permission to be contacted by Sponsor by mail, email, facsimile and telephone. Any personal information collected in connection with this Sweepstakes will be used in accordance with Sponsor's privacy policy. By entering, participants agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. (Residents of Canada may omit return postage.)

3. ELIGIBILITY. The Sweepstakes is open only to "**Resellers**," which for purposes of these Official Rules, is defined to mean individuals who are legal residents of, and business entities that are domiciled in, the 50 United States and the District of Columbia and Canada (except the Province of Quebec), which at the time of entry are: (1) 21 years of age or older (if an individual); (2) registered resellers, integrators or service providers of ScanSource; and (3) in good financial standing with ScanSource. Direct Marketers ("**DMARs**"), "e-tailers," distributors, manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes. Officers, directors, and employees of Sponsor, APG Cash Drawer, and their parents, subsidiaries, and other affiliated companies, agents, and advertising and promotional agencies, and their immediate family members (defined as parents, spouse, children, siblings, grandparents) and those with whom they are domiciled, are NOT eligible to enter or win.

4. SELECTION OF WINNERS/ODDS OF WINNING PRIZE. Sponsor will select prize winners in the two (2) random Sweepstakes drawings described below (the "**Drawings**"), which will be held on or about April 9, 2018 in Greenville, South Carolina.

Limit one (1) prize per Reseller. Odds of winning a particular Drawing depend on the number of eligible entries received in such Drawing.

Skill-Testing Question for Canadian Residents: In the event that a selected potential winner is a Canadian Reseller/resident, in order to win the prize, the Canadian Reseller/resident must first correctly answer unaided a time-limited, mathematical skill-testing question by telephone at a predetermined mutually agreeable time. In the event that the selected Canadian Reseller/resident is unable or otherwise fails to correctly answer the skill-testing question, the Canadian Reseller/resident will forfeit prize, and Sponsor will have the right to randomly draw another eligible potential winner.

Potential winners will be notified by mail, email, telephone, or facsimile. The authorized officer(s) of a winning business entity Reseller will be required to designate the individual recipient(s) of the prize by specifying such individual(s) in writing prior to acceptance of the prize. Potential winner must comply with all of the terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Potential Reseller winners may be required to sign and return an Affidavit of Eligibility and Release (an "Affidavit") within seven (7) days of notification/verification in order to receive the prize. In the event (a) a potential winner cannot be reached for whatever reason after a reasonable effort has been exerted based on the information submitted by potential winner, (b) of noncompliance with the above or within any of the aforesaid time periods, (c) a potential winner is found to be ineligible to enter the Sweepstakes or receive the prize, (d) a potential winner cannot or does not comply with the Official Rules, (e) a potential winner's prize notification or Affidavit is returned as undeliverable for whatever reason, or (f) a potential winner fails to fulfill the Affidavit-related obligations, the potential winner may be disqualified from receiving the prize and/or the Sweepstakes, and Sponsor may, at its sole discretion, award the prize to an alternate potential winner by a random drawing from among the other eligible entries received. Unclaimed prizes may not be awarded.

In the event of a dispute as to the identity of a potential winner based on an email address, the winning entry will be deemed to be the authorized account holder of the email address submitted at time of entry. For purposes hereof, an "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

5. PRIZES. For purposes of the Sweepstakes Drawings only, Sponsor will separate Resellers into two (2) groups: (1) Resellers that, between April 4, 2017 and July 4, 2017, have purchased APG Cash Drawer products from ScanSource ("Current APG Resellers"); and (2) Resellers that, between April 4, 2017 and July 4, 2017, have not purchased APG Cash Drawer products from ScanSource ("New APG Resellers").

Sponsor will award a total of five (5) Grand Prizes through the following two (2) Drawings: (a) the "Current APG Reseller Drawing," through which Sponsor will award four (4) Grand Prizes in a random Drawing from among all eligible Sweepstakes entries received from Current APG Resellers; and (b) the "New APG Reseller Drawing," through which Sponsor will award one (1) Grand Prize in a random Drawing from among all eligible Sweepstakes entries received from New APG Resellers.

In the event that no New APG Reseller Sweepstakes entries are received by Sponsor during the Sweepstakes Period, the one (1) Grand Prize designated to be awarded through the New APG Reseller Drawing will be awarded through the Current APG Reseller Drawing (in which case Sponsor will award a total of five (5) Grand Prizes through the Current APG Reseller Drawing).

Grand Prize consists of a trip for two (2) people to Greenville, SC for three (3) days and two (2) nights and includes: (i) round-trip, coach-class air transportation for two (2) persons from the closest major airport to Grand Prize winner's primary business address to the major airport nearest prize trip destination (airports determined by Sponsor in its sole discretion); (ii) hotel accommodations (one room) for two (2) nights; and (iii) Sponsored group meals and activities (including the opportunity to participate in the BMW Driving Experience and tickets to a Greenville Drive baseball game). Total approximate retail value of Grand Prize: \$2,500; actual value may vary based on airfare and hotel fluctuations, and time of departure and distance between departure and destination.

Grand Prize trip will be on dates determined by Sponsor during the month of May, 2018. At time of acceptance of prize, each Grand Prize winning Reseller must designate the two (2) individual recipients of prize (the "Designated Recipients") who will travel on the Grand Prize trip. (In the event that a Grand Prize winner is an individual, rather than a business entity, the Designated Recipients must include the Grand Prize winner.)

Designated Recipients: (i) must be available to travel on actual dates set for trip by Sponsor; (ii) will be required to sign and return a liability release or will not be permitted to travel on trip; (iii) must travel on the same itinerary and are required to depart from the closest major airport to the Grand Prize winner's primary business address (determined by Sponsor in its sole discretion); (iv) are responsible for providing all travel required identification and travel documents (including passports, if required for travel) and complying with all applicable security requirements; and (v) are responsible for obtaining travel insurance (and all other forms of insurance) at their option, and hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. In the event of the failure to comply with any of the above requirements, winner will forfeit Grand Prize in its entirety and Sponsor may, at its sole discretion, award the prize to an alternate winner. If Grand Prize Designated Recipients cannot travel for any reason whatsoever after all travel arrangements are made, Grand Prize winner may forfeit prize and Sponsor may, at its sole discretion, award the prize to an alternate winner. In the event that Grand Prize winner's primary business address is within 200 miles of trip destination location, ground transportation may be provided to such winner's Designated Recipients in lieu of air travel, and no additional compensation will be provided for travel to and from destination as part of trip prize. (Sponsor is not responsible for transportation of Designated Recipients to airport.)

In the event that the scheduled baseball game or the scheduled BMW Driving Experience is postponed or canceled, Sponsor will not be responsible for awarding such postponed or cancelled portion of the prize and no substitution or compensation will be provided. The remainder of the prize will be awarded. Seating at the baseball game to be determined in the sole discretion of Sponsor. By accepting the baseball ticket and/or the admission to the BMW Driving Experience, each Designated Recipient agrees to abide by any terms, conditions and restrictions provided by the ticket and/or the BMW Driving Experience. Sponsor is not responsible if Designated Recipient does not use ticket/admission on day of event. BMW Driving Experience may be subject to special rules and a separate release (which may be required to be signed by Designated Recipients upon receipt).

Prizes are non-transferable. Unless otherwise specifically provided for herein, all taxes or expenses, including, without limitation, expenses associated with the Grand Prize not specified herein as part of Grand Prize (such as gratuities, incidental charges, surcharges, personal expenses, insurance, telephone charges, and other transportation costs), sales tax, luxury tax, and any other costs incurred in claiming or using any of the prizes, are the sole responsibility of the prize winner. No prize substitution or cash equivalent of prize, except at Sponsor's sole discretion, and then only for a prize of equal or greater value. Any difference between the actual value of any prize and the approximate retail value set forth in these Official Rules may not be claimed and will not be awarded.

6. GENERAL CONDITIONS.

(A) This Sweepstakes is subject to all federal, state and local laws and regulations. The laws of the United States of America shall be deemed to govern the Sweepstakes.

(B) Acceptance of prize shall constitute and signify the winning Reseller's agreement and consent that Sponsor may use winning Reseller's and Designated Recipients' (and if applicable, Reseller's corporate representatives') name(s), address(es) (city and state only), biographical data, voice, likeness, image, statements, and prize information, in any and all media now existing or hereafter devised for illustration, promotion, art, editorial, advertising, trade or any other purpose whatsoever, in perpetuity, without attribution, notification, compensation or consents (except where prohibited by law), and winning Reseller hereby releases Sponsor from any liability with respect thereto. (Canadian residents need not consent to, or sign any, publicity release.)

(C) Participant, by participating, releases and agrees to hold harmless Sponsor, APG Cash Drawer, and their parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and their respective directors, officers, employees, representatives and agents from any and all liability for any accident, loss, tax liability, injury, death or damage of any kind, arising from participant's

participation in this Sweepstakes or in any Sweepstakes related activity, or resulting from acceptance, possession, use or misuse of any prize, or while traveling to and/or from a location as part of or to obtain or use a prize. Without limiting the foregoing, all prizes are provided “as is” without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement.

(D) Sponsor and its parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and contest administrators and their respective directors, officers, employees, representatives and agents are not responsible for any typographical or other error in the printing of the Sweepstakes, administration of the Sweepstakes or in the announcement of the prizes. Sponsor reserves the right to modify the Sweepstakes rules, terms and conditions without materially affecting the terms and conditions of the Sweepstakes.

(E) Except where prohibited, participants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or any prize awarded, or the determination of the winners shall be resolved individually, without resort to any form of class action, and exclusively under the laws of the State of South Carolina, USA and through the courts of Greenville County, South Carolina, USA; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes but in no event attorneys’ fees; and (3) under no circumstances will participants be permitted to obtain awards for and participants hereby waive all rights to claim punitive damages, incidental damages, consequential damages or any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. (NOTE: Some jurisdictions do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above may not apply to all Resellers.) All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant or Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of South Carolina, USA without giving effect to any choice of law or conflict of law provisions.

(F) If for any reason the Sweepstakes is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right at its sole discretion, to disqualify any participant who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. In the event of the cancellation, termination, or suspension of the Sweepstakes, Sponsor may award prizes in a random drawing from all eligible entries received up to the date of termination, cancellation or suspension.

(G) Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, registrations or entries. Sponsor is not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any registration, email or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to a participant’s or any other person’s computer relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes.

(H) **WARNING: ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE THE SWEEPSTAKES WEBSITE (OR ANY SPONSOR WEBSITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH**

PERSON(S) TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING SEEKING CRIMINAL PROSECUTION.

8. SPONSOR. The Sponsor of this Sweepstakes is ScanSource, Inc., 6 Logue Court, Greenville, SC 29615 (USA). The administrator/operator of this Sweepstakes is Sponsor.
